The investment objective for the Eden Park Money Market Portfolio is to provide access to attractive institutional cash returns with daily liquidity.

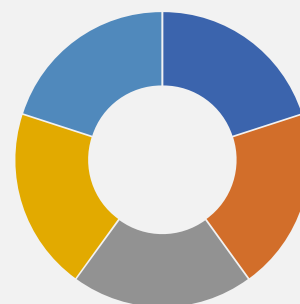
